WELCOME TO EDHEC



SETTLING IN FRANCE MADE EASY

Moving to a foreign country can be daunting. It is reassuring, therefore, to know that you can rely on the International Students Office (ISO), which welcomes more than 2,000 international students annually, to help you settle in smoothly. The ISO team helps EDHEC's international students with all kinds of administrative matters and is there to lend them support in daily life.

INTERNATIONAL STUDENTS OFFICE

— A team you can trust

The ISO assists students with all administrative procedures prior to their arrival on campus and helps them to adapt to life in France. To support students during their transition, ISO organises webinars on accommodation and visa topics. The team is ready to help students with questions related to immigration, the French medical system, medical insurance, opening a bank account and much more.

ACCOMMODATION

— Finding you a home away from home

The ISO helps students to find suitable accommodation and assists them in communicating with landlords throughout their stay in France in case of any language barriers.

SETTLING IN

— Meeting your new friends

Each year, the International Students Office organises orientation events and integration seminars to welcome international students to the EDHEC campuses. We also provide a free transfer service for international students from the train station or airport in Nice or Lille to their chosen accommodation.

VISAS AND RESIDENCE PERMITS

— Untangling the red tape

EU nationals

European Union students can live and study in France as long as they have a national ID card. No passport or visa are required.

Non-EU nationals

Before arriving in France, students from outside the European Union must have a valid passport from their country of origin. They must also obtain a student visa from the French embassy or consulate in their country of origin or permanent residence.

FRENCH CLASSES

— Parlez-vous français ?

French language courses are offered free of charge to facilitate your stay in France.



EDHEC's Master in Management is accredited by CEFDG conferring the grade Master level from the French Ministry of Higher Education. Enrolled students are eligible for an Autorisation provisoire de séjour (APS) or Carte de séjour recherche d'emploi - création d'entreprise (CSRCE), at the end of the programme.

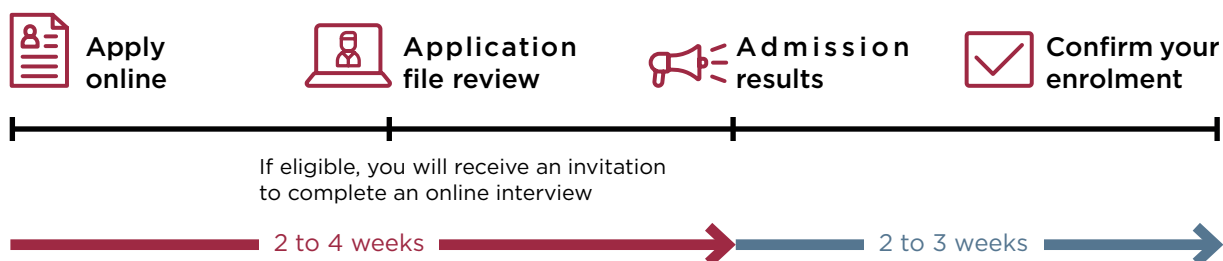
